IMPORTANT NOTES

- 1. Membership Dues and Equipment Fund contributions may be paidmonthly, quarterly, bi-annually, or annually. Credit cards are charged automatically.
- Miami Rowing Club is a not-for-profit institution that relies on its members' support to update and maintain a fleet of rowing shells and other rowing equipment. Family, Individuals 27+ andIndividual Under 27 Members are required to makea tax-deductible contribution to the Club's Equipment Fund of \$25 monthly or \$300 annually.
- 3. Additionally, every active Member (Family, Individual 27+, or Individual Under 27) must volunteer for at least 10 hours annually. Volunteer activities may include help with the maintenance of equipment, support for the Miami International Regatta, or other activities that will improve or enhance the Club and its environment. Members who are unable to or choose not to volunteer in a particular year are charged an additional fee of

\$125 following the end of the 1calendar year. (Don't apply for Catamaran Storage)

Any program member should be outside the facilities 30 minutes before closing MRC.

Member is responsible for all your equipment, and MRC is not responsible for any loss, theft, or another equipment issue.

We recommend that you have your own insurance. MRC insurance does NOT COVER ANY PERSONAL PROPERTY OR EQUIPMENT IN MRC,

PAYMENT PROCEDURES:

- Pay by credit card: You can use master, VISA, Discover, etc. We don't accept AMERICAN EXPRESS
 - Your account will be billed automatically by keeping your credit card information on file. You will be notified by email when a payment is made against your account. Please email the attached Credit Card Authorization Form to Miami Rowing Club <office.miamirowing@gmail.com>
 - 2. You may pay dues annually, bi-annually, or monthly.
- Payment amount must include:
 - The appropriate initiation fees.
 - The first month's dues.
 - Private boat accommodations if a space has been confirmed. Pro-rated if necessary.
 - Membership status requires payment of dues regardless of non-use of the club by the member.
- Membership will be effective after receipt of payment and billing information and notification of acceptance by the Membership Committee.

BILLING PROCEDURES:

- The Miami Rowing Club does not send invoices or statements.
- Your account will be debited monthly, bi-annually, or annually against your credit card or bank account.

MEMBERSHIP CHANGES, FREEZE, OR CANCELLATION:

- Changes:
 - Requests for any changes in membership status must be made in writing to the MRC General Manager 30 days before the change takes effect.
 - The Membership Committee must approve changes.
- Cancellation:
 - Submit notification of cancellation in writing to the office at: office.miamirowing@gmail.com 30 days before termination.
 - Members leaving the club in good standing enjoy MRC Alumni status and may rejoin at a later date for half of the current initiation fee. Application for alum status must be made in writing.
- Freeze
 - You may freeze your membership for anticipated absences more significant than three months and less than one year. The admin fee to freeze is \$35.00. The request must be made to the office in writing. The freeze will become effective on the 1st of the month following the written request.

Release of Liability

IN CONSIDERATION of being allowed to participate in any rowing activity, including scheduling, supervised club activities during the dates listed below, I, for myself, my representatives, assigns, and next of:

- 1. ACKNOWLEDGE, agree, and represent that I understand the nature of Rowing Activities, both on water and land-based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity.
- 2. FULLY UNDERSTAND that: (a.) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of severe bodily injury, including permanent disability, paralysis, and death ("Risks"); (b.) these Risks and dangers may be caused by my actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Release named below; (c.) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.
- 3. AGREE AND WARRANT that I will examine and inspect each Activity in which I participate as a participant in Miami Rowing Club programs and that, if I observe any condition that I consider unacceptably hazardous, I will notify the proper authority in charge of the Activity. I will only take part in the Activity once the situation has been corrected to my satisfaction.
- 4. At this moment, RELEASE, discharge, and covenant not to sue the Miami Rowing Club, their administrators, directors, agents, officers, volunteers, and employees, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the Releases herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Release or otherwise, including negligent rescue operations; and I further agree that if despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, claims any of the Releases, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releases from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim, to the fullest extent permitted by law.
 - 5. I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the ba lance, notwithstanding, shall continue in full force and effect.

6. All private boats are the entire responsibility of the owner. MRC and the City of Miami are not responsible for any loss, damage, or

any other situation in the area where you have your boat. In case of a storm, you are responsible for moving or keeping your boat

safe; you discharge and covenant not to sue the Miami Rowing and water sports center, their administration, directors, agents,

officers, volunteers, and employers for any situation with your boat. The insurance of MRC does not cover any private boat. Is the

owner your entire responsibility?
